59% of eligible children


86% of eligible infants

Investing in a Wellness Oriented Workforce

The WIC workforce is California's largest nutrition and lactation workforce. Numbering about 3,300, the employees serving at CDPH and in the WIC local agencies are exceptionally dedicated and committed to prevention and wellness promotion.

- WIC staff are culturally and linguistically aligned with local communities
- WIC staff bring lived experiences relevant to local communities
- Many WIC staff members are current or former WIC participants
- WIC staff develop long-term relationships with families (Perinatal-Early childhood-Multiple children)
- WIC staff include fathers and other partners engaged in supporting family health
- WIC agencies hire and promote from the community
- WIC staff are trusted members of the community who understand local health and social priorities



Building on Statewide WIC Infrastructure: *Partnerships and Referrals*

- Support innovations to ensure accurate and complete WIC referrals.
- Facilitate electronic bidirectional referrals through EHR/HIE/CIE.
- Make bi-directional communication with providers for care coordination easier and more efficient.
- Use MCP reports on WIC referrals and collaborative QI agreements to encourage closer collaboration between MCPs and WIC local agencies.
- Implement updated MCP and WIC local agency MOU statewide to strengthen partnerships and communication.

Building on
Statewide WIC
Infrastructure:

Capacity in

- Streamline Medi-Cal enrollment for WIC agencies for braided USDA and Medi-Cal funding streams.
- Create an efficient path for WIC agencies to contract with managed care plans.
- Facilitate the certification process for WIC Nutrition Assistants co-train as CHWs.
- Facilitate the process for WIC staff co-train as Behavioral Peer Specialists, housing navigators, asthma management educators, and case managers.

Building on WIC Infrastructure: *Perinatal and Early Childhood Population Health Management*

- Leverage risk stratification within [WIC eligibility assessment](#) and [Nutrition Assessment](#) to inform clinical and social needs assessments in PHM.
- Build on statewide WIC workforce to expand wellness support services for perinatal and early childhood populations.
- Build on existing trusted relationships and facilitate MCP contracting with WIC staff to serve as care managers for perinatal hospital care transitions.
