<ul style="list-style-type: none"> <li>• Disaster Response</li> <li>• Pandemic Response</li> </ul>	Access to real-time information for individuals and populations that can be used to rapidly mobilize and respond to specific needs including physical and mental health needs.	Allow for disaster response teams to pull clinical pharmacy and summary data at the point of care. Push clinical and claims data to state public health registries and policy teams for reporting and needs assessment purposes (e.g., available hospital beds, test results, vaccination tracking).	<ul style="list-style-type: none"> <li>• Individual patient transactions</li> <li>• Population-level transactions</li> </ul>	✓
<ul style="list-style-type: none"> <li>• Serving patients with complex needs</li> </ul>	Supporting continuity of care and timely follow-up by delivering messages among hospitals, health plan care managers, prior authorization systems and primary care providers.	Push ADT alerts, care plans, and pharmacy data to providers, plans, and other organizations.	<ul style="list-style-type: none"> <li>• Individual patient transactions</li> </ul>	✓
<ul style="list-style-type: none"> <li>• Quality/VBP</li> </ul>	Improving quality performance with data extracts for HEDIS and other programs.	Push bulk data downloads of clinical and claims data to health plans for quality reporting purposes. Allow for plans to pull data on specific patients for quality Improvement purposes.	<ul style="list-style-type: none"> <li>• Population-level transactions</li> </ul>	✓
